

Emirates First Ball Flyer

One wicket. Two tickets. Simple as that.

Terms and Conditions

These terms and conditions ("Terms and Conditions") set out the basis on which you can participate in the Competition ("Competition"). By entering the Competition, you accept these Terms and Conditions in full. If you do not accept these Terms and Conditions, you should not enter the Competition and you will not be eligible to win the prize.

Winning members and their selected guest will be asked to sign and complete an imagery consent form so that imagery and video of winners can be captured. You should only enter the Competition if you and your selected guest are comfortable being filmed and photographed for this purpose.

1. **COMPETITION PERIOD:** The start date of the first match is Monday 25 May at 10:30 (UK time) ("**Start Date**"). The closing date of the final match is Sunday 12 July at 15:00 (UK time) ("**Closing Date**").
2. **PRIZE RESTRICTIONS:** The prize is non-transferable, non-extendable, non-endorsable and no cash alternative will be offered. The relevant prize will be determined by Lancashire Cricket in its sole discretion and will be given to one member of the audience, who will be chosen at random, at Emirates Old Trafford during Lancashire Men's T20s or Lancashire Men's & Women's T20 Double Headers.

If you are selected as the Winner and you or your guest are unable to travel within the travel time stipulated below (clause 3), the Prize will be forfeited and no alternative will be offered.

The Prize consists only of the elements expressly set out in these Terms and Conditions and no other elements or expenses (including, without limitation, visas, any additional expenses relating to your flight, hotels, taxis, insurance, meals, phone calls, baggage, gratuities, incidentals, souvenirs, fuel costs, car parking charges, personal expenses) are included in the Prize and all such expenses are the responsibility of the Winner and their guest. Proof of identity will be needed on point of booking and will be confirmed against the records that we hold on to you for confirmation of attendance.

These tickets are not valid for travel during blackout periods assigned to these destinations. Any blackout dates, if applicable, will be advised at the time of booking.

Once tickets are issued, any change in date is subject to a fee payable by the competition winner.

These tickets are valid on Emirates Airlines only and are non-extendable, non-transferable, non-re-routable, non-endorsable, and non-encashable.

The prize winner is entitled to the normal baggage allowance as per the existing rules.

No Skywards Miles can be redeemed on these tickets.

3. **PRIZE:** One winner will receive 2 x return economy flight tickets from Manchester to Cape Town (South Africa) on Emirates flights as described in these Terms and Conditions. The tickets need to be booked within three months from the date of issue on Economy and travel must occur within six months of winning the prize.
4. **ELIGIBILITY:** In order to enter the Competition, you must be aged 18 or over (and if your selected guest is aged under 18, the consent of a guardian will be required, and they must be accompanied by you at all times). The winner will need to have a valid general admission or hospitality ticket to the match on the day that the winner is chosen.
5. Employees of Lancashire Cricket Club LTD (company number 28451R) ("**Lancashire**") The Emirates Group ("**Emirates**") or members of their immediate families are not eligible to enter the Competition.
6. Lancashire Cricket and Emirates reserve the right to substitute the Prize(s) (or any part of it/them) for a prize or prizes of equivalent or greater monetary value if this is necessary for reasons beyond its control. There is no cash alternative to the Prize (or any part of them) and unless agreed otherwise in writing the Prize is non-refundable and non-transferable. All costs and expenses not included within the Prize are the responsibility of the winner.
7. **ENTRY:** You will be automatically entered into the competition if you purchase a general admission or hospitality ticket for Lancashire Men's T20s or Lancashire men's & Women's T20 Double Headers at Emirates Old Trafford in 2026 and are sat in your seat for the first ball of the Lancashire Men's or Lancashire Women's innings on each match day.
8. **SELECTION OF WINNER:** If Lancashire take a wicket with the first ball of their innings then a winner will be chosen at random at the end of the first over and announced live in-bowl at Emirates Old Trafford on that given match day. The winner will be picked at random from all eligible entries on that day. A member of Lancashire Cricket staff will get contact details of the winner on the matchday and official confirmation shared by email within 1 day of the match. The winner must respond within 2 days to claim their prize. The winner must allow for Lancashire Cricket to contact them via email.
9. Third party terms and conditions apply to parts of the Prize where applicable.
10. The winner will be contacted using the contact details provided within 2 days of the match. If the winner cannot be contacted or does not respond to confirm details for delivery of the Prize within 2 days, an alternative winner will be selected at random from the remaining eligible entries.
11. **PUBLICITY AND PERSONAL DATA:** the winner agrees to take part in reasonable publicity relating to the Competition and Emirates and/or Lancashire Cricket may use footage of the winner, the winner's name and image and his/her comments relating to the Competition and/or the Prize for future promotional, marketing and publicity purposes in any media worldwide without notice and without any fee being paid.
12. Details of the winner's name and country will be available on request for one month after the Closing Date by writing to the Promoter (including providing a stamped self-addressed envelope and stating the name and closing date of the Competition) at the address set out below.

Any such entries will be deemed void.
15. The Promoter reserves the right to withdraw or amend the Competition or these Terms and Conditions if circumstances outside its reasonable control make this unavoidable.
16. Entries must be strictly in accordance with these Terms and Conditions. Any entry not in strict accordance with these Terms and Conditions will be deemed to be invalid and the Prize will not be awarded in respect of such entry. The Promoter reserves the right to verify the eligibility of any entrant and to exclude any entries which it believes to be invalid or in breach of these Terms and Conditions.
17. The Promoter's decision is final in all matters relating to the Competition (including the Prize) and no correspondence will be entered into.
18. Except in respect of death or personal injury resulting from any negligence of Lancashire Cricket or Emirates, to the maximum extent permitted by law, neither Lancashire nor any of its officers, employees or agents shall be responsible for (whether in tort, contract or otherwise):
 - i. any loss, damage or injury to you and/or any third party or to any property belonging to you or any third party in connection with the Competition and/or the Prize (including the winner's receipt or use of the same), resulting from any cause whatsoever; or
 - ii. any loss of profit, loss of use, loss of opportunity or any indirect, economic or consequential losses whatsoever and howsoever caused.
19. **GOVERNING LAW AND JURISDICTION:** Please note that these Terms and Conditions are governed by English law. This means that your entry into the Competition and any dispute or claim arising out of or in connection with it will be governed by English law. You and the Promoter both agree that the courts of England and Wales will have non-exclusive jurisdiction in connection with any such dispute or claim.
20. **SPIRIT OF THE COMPETITION:** If you attempt to compromise the integrity or proper operation of the Competition by cheating or committing fraud in any way, Lancashire Cricket and Emirates each reserve the right to render your entry invalid, seek damages from you and ban you from participating in any of their future competitions.
